Be reminded that participation is voluntary and shall be subjected to the non-disruption of classes policy stipulated in DepEd Order No. 9, s. 2005 titled, "Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith and the policy off-campus on activities stated DepEd Order No. 66, s. 2017.


