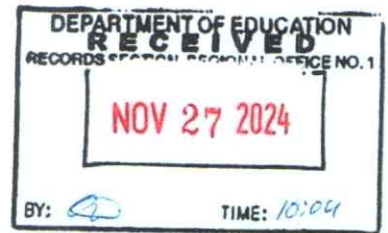

SUBJECT : MONITORING OF PRIVATE SCHOOLS PARTICIPATING IN THE GOVERNMENT ASSISTANCE AND SUBSIDIES (GAS) PROGRAMS



This refers to the agreements made during the Orientation and Consultation with Schools Division Superintendents (SDSs) on Government Assistance and Subsidies (GAS) Programs, Visayas Cluster on October 1-4, 2024 and Mindanao Cluster on October 7-10, 2024.

Pursuant to DepEd Order (DO) No. 88, s. 2010 otherwise known as the 2010 Revised Manual of Regulations for Private Schools in Basic Education, all private educational institutions shall be subject to reasonable supervision and regulation by the Department of Education. In relation to this, it was recommended by the SDSs that the Regional Offices (ROs) and Schools Division Offices (SDO) be provided with the list of GAS participating schools which can use as a basis for monitoring their performance and compliance in the GAS programs.

This Office reiterates the authority of DepEd ROs and SDOs to oversee the performance and compliance of these schools in the GAS programs.

In this regard, this Office shares the list of participating private schools in the Educational Service Contracting (ESC) and Senior High School Voucher Program (SHSVP) through the link the link <https://bit.ly/4fFmYqq>.

Should there be any negative or suspicious findings, you may submit a brief report to this Office for its information and appropriate action.
