SUBJECT:

2025 REGIONAL SCOUT YOUTH FORUM

1. We are pleased to announce the conduct of the 2025 Ilocos Region Scout Youth Forum with the following details:

Date:

14-16 March 2025

(Arrival is 1300hrs for registration, Opening is 1400hrs)

Venue:

Sta. Maria National HS, Sta. Maria, Ilocos Sur

Participation:

Each council shall send not less than three official voting Delegates and one observer to make the discussion livelier and more productive. Official voting delegates shall at least fifteen years old (Grade 9 to 11 and who wants to remain with the senior scouting program) and preferably Outdoorsman in rank and shall be elected as Council Scout Representative in their

respective Council Scout Youth Forum.

For the requirement of at least sending the agreed minimum participation of four, there should be at least one female

participant.

A council may send more than the agreed participants and are

encouraged to increase female participation.

The Council who failed to send participants shall likewise pay the corresponding registration fee for administration purposes.

Things to Bring: Participants shall bring their own sleeping gears, type A uniform,

smart casual wears, senior scout neckerchief which will be worn

at all times.

One participant from each local council is encouraged to bring a

laptop for encoding and presentation.

Forum Fee:

One thousand pesos (P 1,000.00) shall be charged each participant and observer. This shall cover meals & snacks (afternoon snacks of 14 March until lunch of 16 March 2025), forum materials and other administrative expense. The fee for

- Accompanying adult leaders shall bring their own sleeping gears. They will be provided with their own sleeping quarters and will be issued certificate of appearance & certificate of recognition. They have to bring their own sleeping gears and buy their own meals at their own expense.
- 3. Prior to the Regional Scout Youth Forum, Local Councils shall conduct their own Council Scout Youth Forum not only for the purpose of determining who shall attend the Regional Scout Youth Forum but also the young people's voice at the Council Executive Board. Once the forum was conducted, Council Scout Executive shall transmit the list of the attendees for records and other forum preparation immediately to the regional office.
- 4. Deadline for submission of participation shall be on or before 10 March 2025 either by soft copy to the regional office email address of <a href="mailto:bsp.irco@scouts.gov.ph">bsp.irco@scouts.gov.ph</a> or hard copy to the regional office with the corresponding forum proceedings.
- 5. All Council Scout Executives shall make the necessary and facilitate the official release and travel of their respective participants. Local Councils are enjoined to pay for the forum fee of their respective participants or other contingencies as support to their participants and can be charged under item scout activities in their proposed budget should the budget allows. In the event that no adult leader shall accompany their official scouts attending, Council Scout Executives and Council staff may accompany their participants but are discouraged to charge their accommodation (per diem) with the local council fund to minimize travel expense. They should inform the host executive of their presence to facilitate their sleeping gears.
- 6. If elected as Regional Representative, the scout shall ensure that he is allowed to attend the National Scout Youth Forum in Nueva Ecija, otherwise, he will be paying the equivalent registration fee of attendees who are not official voting delegates.
- 7. All concerned are enjoined to give outmost support and preferential attention to this memorandum.
- 8. For your information and compliance.
