 - b. Request an MP2 Enrollment Form.
 - c. Fill out the form with your information, including your Pag-IBIG MID number, desired monthly contribution, dividend payout preference, and payment method.
 - d. Submit the form along with:
 - Photocopy of a valid government-issued ID.
 - 2. Proof of income (pay slip, deposit/savings acct, etc.).
 - e. Deposit the initial savings.
