- ANYO: Must be Ethnic Asian or will vary discretion of players as long as related to Arnis.
- COACHES: Organizing Committee will provide VEST to be wear all coaches during his /her player fight.
- PROHIBITED: Slippers, Shorts, Sando and Wearing cap OR BONNET.

#### X. Requirements:

- Proof of age for below 17 years old-MANDATORY.
- Individual Eligibility Form-MANDATORY.
- With Waiver/ Sign of parent/guardian.

#### XI. Rules / Officiating:

- PEKAF Rules will apply with local revision.
- · Only invited R/J Officials.
- PRO-ACTIVE License R/J Officials

#### XII. Rules of the Game:

- . Padded: Time Allotted: 1min, 30 secs in all ages, raised to 7 points: Under 17 y.o below
- . For 18 above: Elimination to Semis: 1 min, 30 secs and for Finals best of 3 rounds: 1min, raised to 5 points.
- . Live Stick: 30 secs for Men, 25 secs for Women every Round.
- . Anyo: 3 judges- Total Score, Highest Point WIN
- . In-case of Tie: With LOWER SCORE LOOSER, In-case with same lowest score, next is with the highest score given by the judge. So in-case same lowest score and highest score repeat performance.

#### XIII. Awards:

- Top 3 teams (Placer)will receive TROPHY.
- Special Award: Most number of Participants, Best Coach Award
- Medal shall be award for every winners.
- Certificate of participation, Coach, Officials will be given.
