HISTOQUIZ 2025

1. Proclamation No. 339, series of 2012, designates the month of August as History Month, extending the former observance of History Week (previously celebrated from September 15 to 21) to an entire month. This adjustment seeks to offer Filipinos a longer and more meaningful opportunity to reflect on and celebrate the nation's rich historical legacy.
2. Moreover, Proclamation No. 282 (which amends Proclamation No. 1008 issued in 1997), designates August as the Association of Southeast Asian Nations (ASEAN) Month in the Philippines. The goal of this designation is to "further strengthen and heighten awareness of the ASEAN and instill in the minds of the Filipino people, the importance, value, and meaning of the ASEAN in achieving and maintaining regional peace and sustainable development.
3. Anent these, the Schools Division of the City of Batac (SDCB) through the Curriculum Implementation Division (CID) shall conduct the HistoQuiz 2025 on September 4 from 8:00 am to 5:00 pm at the Hilario Valdez Memorial Elementary School Conference Hall. The activity is part of the PAMANA (PAGpapahalaga sa MAYamang NAKaraan) program in celebration of the National Heroes Day, History and ASEAN Month.
4. The activity aims to deepen learners' understanding and appreciation of Philippine history and ASEAN, while fostering critical thinking and spirit of camaraderie among participants.

Enclosure 2. General Guidelines

1. The HistoQuiz 2025 is open to all learners with Learner Reference Number (LRN) who are officially enrolled in the public and private schools for School Year 2025-2026.
2. Each elementary school must have only one (1) contestant and one (1) coach, while each secondary school is allowed a maximum of three (3) contestants and one (1) coach.
3. The test items are focused on topics related to History, Association of Southeast Asian Nations (ASEAN), as well as local and national heroes.
4. All participants shall receive Certificate of Participation from the Schools Division of the City of Batac (SDCB) through the Curriculum Implementation Division (CID).
5. Certificates of Recognition will be awarded to the top five (5) scorers and their coach. Tie-breaking questions shall be conducted if necessary.
6. The participation of all schools is highly encouraged.

<p>A. The quiz is open to all types of learners who are officially enrolled in grades 4-6.</p> <p>B. Each school shall have one learner-contestant from Grades 4 to 6.</p> <p>C. Learner-contestants are required to bring a whiteboard (approximately 12x18 inches in size), a whiteboard marker, and an eraser.</p> <p>D. Filipino shall be used as the official language in the conduct of the quiz.</p> <p>E. Learner-contestants shall be given a total number of twenty-four (24) questions, of which nine (9) are easy, eight (8) are average and seven (7) are difficult.</p> <p>F. Points for every correct answer shall be given as follows: One (1) point for “easy” questions, two (2) points for average questions and three (3) points for “difficult” questions. In case of a tie, a clincher question drawn from the “difficult” category shall be asked.</p> <p>G.
