REQUEST FOR LEARNER-RESPONDENTS TO UNICEF'S U-REPORT POLL

1. Relative to the Unnumbered Memorandum from the Office of the Undersecretary for Operations dated July 28, 2025, and Panrehiyong Memorandum No. 1097 from the Office of the Regional Director titled Request for Learner-Respondents to UNICEF's U-Report Poll, learners born between 1995 and 2024 (ages 13–30 this year) are requested to participate in the survey.
2. This initiative is led by the National Committee on Child and Youth Participation (NCCYP) to address the lack of comprehensive data on youth participation nationwide. The survey aims to gather insights that will guide the development of the Framework and shape future policies, programs, and activities for children and youth.
3. The Poll consists of six (6) multiple-choice questions, available in both English and Filipino, focusing on children's and youth perspectives on participation and engagement. Respondents may access the Poll by logging in to their Facebook Messenger accounts, searching for U-Report Philippines, and sending "VOICE" to start answering.
4. To meet the target number of respondents, all public and private secondary schools are encouraged to participate by ensuring at least five (5) learner-respondents on or before September 5, 2025. Schools may exceed this target if desired.
5. Each learner-respondent and their parent/guardian must accomplish the Learner and Parental Consent Forms. Consolidated accomplished forms must be submitted to the SGOD Office before the deadline to facilitate timely submission to higher authorities
6. Attached are the official memoranda from the Office of the Undersecretary for Operations and the Office of the Regional Director, along with Annex A (Learner and Parental Consent Forms), for reference.
