**DEDP MEDIUM TERM REVIEW FOR FY 2026-2028**

1. Republic Act 9155 otherwise known as the Governance of Basic Education Act of 2001 provides that the School Division Office (SDO), through the leadership of the Schools Division Superintendent, shall develop and implement the Division Education Development Plan (DEDP). The DEDP is aligned with the provisions of DepEd Order No. 24, s. 2022 otherwise known as the Adoption of the Basic Education Development Plan 2030. However, it is significant to conduct a medium-term review at the midpoint of implementation at the end of Year 3.
2. Relative to this, the Schools Division Office through the School Governance and Operation Division shall conduct the DEDP Medium Term Review for Fiscal Years 2026-2028 on August 11 and 18, 2025, at the Bulwagan ng Karunungan, Schools Division Office, City of Batac.

  - b. Evaluate the effectiveness of strategies and relevance considering new circumstances, and
  - c. Determine the likelihood of realizing targets.
