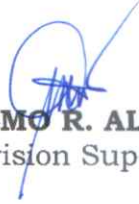
- attend the general orientation meeting on the scheduled interview date;

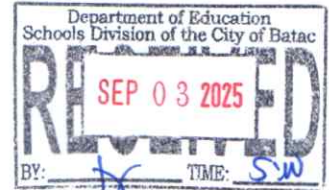
