

The designated chaperones who shall render meritorious service during the conduct of the activity shall be granted service credits for teaching personnel and compensatory time-off (CTO) pursuant to DepEd Order 53, s. 2003 on the Updated Guidelines on Grant of Vacation Service Credit for Teachers.
7. This memorandum serves as the Authority to Travel for all participants, contingent upon securing appropriate parental consent for learners (see attached template)

PARENTAL CONSENT AND WAIVER FORM

I, _____, as the parent or legal guardian of _____, hereby acknowledge that I have been informed of the details of the conduct of the **3rd MANGIDAULO REHIYON UNO: REGIONAL LEARNERS' CONVERGENCE** that will be held on **January 13-16, 2026** at **El Pescador Resort Hotel, San Andres St., Bolinao, Pangasinan**

I understand that the Education Support Services Division – Youth Formation Division of the Regional Office I shall implement the minimum public health standards set by the government to minimize the risk of the spread of any communicable disease, but it cannot guarantee that my child will not become infected.

Declining or withdrawing participation will not result in any penalty or loss of benefits or reduction of any basic right to which my child is entitled. While there remains the risk of possible transmission of any communicable disease to my child/ren, and to the members of my household, I freely assume the said risk and I permit my child/ren to attend this activity.

Exclusion (Limitations/Ineligibility)

I am aware that symptoms of any communicable disease include, but are not limited to, fever or chills, cough, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, the new loss of taste or smell, sore throat, congestion or runny nose, nausea, vomiting, and diarrhea.

I confirm that my child currently has none of those symptoms and is in good health. I will not allow my child to physically go to the event if my child or any member of my household develops any of the said symptoms or any other symptoms of illness that may or may not be related to any communicable disease. I will also inform the school/division and not allow my child to attend the event if my child or any of my household members test positive for any communicable disease. My child/ren and I, with my household members, will follow the required health and safety protocols and procedures adopted by the school and community.

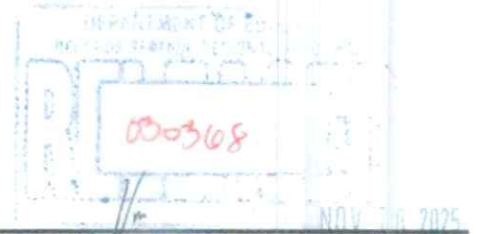
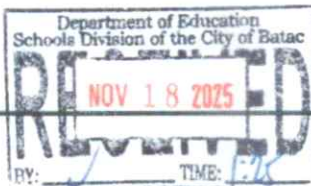

**REGIONAL MEMORANDUM**No. 1577 s. 2025**3RD MANGIDAULO REHIYON UNO: REGIONAL LEARNERS' CONVERGENCE**

To: Schools Division Superintendents

1. In line with the commitment to the holistic development of learners and in accordance with legal directives, the Education Support Services Division – Youth Formation Division, will conduct the 3rd Mangidaulo Rehiyon Uno: Regional Learners' Convergence.
2. The convergence, originally scheduled on November 18 – 21, 2025 will be moved to **January 13-16, 2026** at **El Pescador Resort Hotel, San Andres St, Bolinao, Pangasinan**.
3. This activity is anchored in the legal bases provided by Memorandum OUOPS No. 2023-03 and DepEd Order 31, s. 2022 and aims to unify advocates of DepEd learner formation in Region I, promote collaboration and establish a robust foundation for the upcoming school year with the following objectives:
 - a. To facilitate interactive thematic learning sessions for identified learner leaders, guided by teacher-advisers and division learner formation coordinators from the 14 Schools Divisions of DepEd Region I.
 - b. To formulate the Regional Plan of Action (RPOA) for SY 2025-2026 for the Regional Federated Supreme Elementary Learner Government (RFSELG) and Regional Federated Supreme Secondary Learner Government (RFSSLG).
 - c. To officiate the induction of regional federated officers (learners) and their teacher-advisers for RFSELG and RFSSLG.
4. Expected outputs:
 - a. Engaged learner leaders, teacher-advisers, and division learner formation coordinators with expansive knowledge in thematic learning areas facilitated by the Learner Formation Division.
 - b. The finalized RPOA for SY 2025-2026 (slated for implementation in the upcoming school year).

- i. Division Federated Supreme Elementary Learner Government Teacher-Adviser (President)


