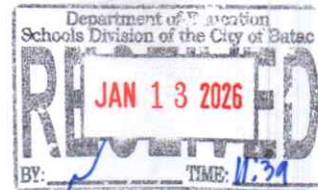

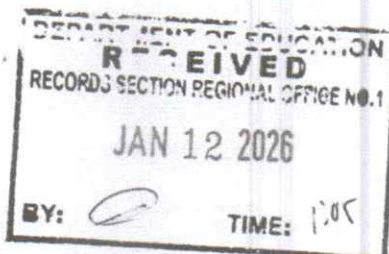

Internal quality audit aims to provide an objective evaluation of the effectiveness of the established quality management system of DepEd. As stipulated in the PAWIM-P-003 5.1.1, the selection of candidate auditors into the auditor pool should have knowledge on 19011:2018 – Auditing Management Systems (acquired through training) and knowledge of the ISO 9001:2015 requirements and QMS Manual (acquired through training and orientations. Kindly take note that the mentioned ISO trainings can be provided by any person (internal or external to DepEd) who has undergone and passed the examination of a five-day CQI-IRCA certified Lead Auditor Training Course.

In line with our continuing efforts to strengthen the National Quality Management System (NQMS) implementation across DepEd offices, we will be conducting a profiling of internal quality auditors of DepEd offices from Central Office down to Schools Division level. This initiative aims to establish a master list of personnel who have undergone trainings on ISO 9001:2015 Quality Management Systems and ISO 19011:2018 Guidelines for Auditing Management Systems that can compose the IQA Teams across DepEd offices.
