GUIDELINES ON THE CONDUCT OF THE NATIONAL ASSESSMENT FOR SCHOOL HEADS (NASH) PROFESSIONAL DEVELOPMENT INTERVENTION (PDI)

To: Schools Division Superintendents

1. Aligned to its mandate to provide structured and standards-based professional development as a special support mechanism for leadership readiness and career advancement, the National Educators Academy of the Philippines (NEAP), as the professional development arm of the Department of Education (DepEd) and by virtue of the Republic Act No. 12288 titled *Expanded Career Progression for Public School Teachers and School Leaders*, provides the guidelines for the NASH Professional Development Intervention (PDI) to address the identified competency gaps, strengthen the school heads pipeline, and operationalize NASH as a diagnostic-to-development continuum.

2. The NASH PDI shall cover aspiring school heads who have undergone the NASH and categorized as **meeting the minimum overall rating, with identified domain-level developmental needs on their assessment results**. NASH PDI participants shall undergo domain-based professional development and are required to complete eLearning corresponding to one or more PPSSH domains identified in their Individual Development Report (IDR).


