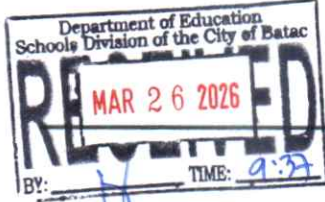

The Philippine Commission on Women (PCW), through its National GAD Resource Program (NGRP), continues to deliver timely and relevant technical assistance (TA) on gender and development (GAD) to national government agencies, state universities and colleges, government-owned and controlled corporations, and other government institutions. A key component of the NGRP is its GAD Technical Assistance Platform, which covers the provision of individual TA, sectoral, and public TA offerings, as well as GAD webinars.

2. The GAD webinars are developed to reach a broad range of government stakeholders, offering accessible, flexible, and self-paced learning opportunities. Since 2020, these webinars have supported policymakers, government personnel, GAD practitioners, and the general public in deepening their understanding of gender mainstreaming and acquiring practical tools and knowledge that can be applied within their respective institutions and sectors.

3. Building on this strong foundation and the sustained impact of the GAD webinar series, four (4) specialized webinars will be conducted for Fiscal Year (FY) 2026 to address emerging issues and current technical assistance needs, as follows:

- a. **GAD Webinar 1: Kasarian Noon at Ngayon: Decolonizing Gender from Pre-Colonial Societies to Contemporary GAD Practice (March 25, 2026)** – exploring historical perspectives on gender and how these inform contemporary GAD policies and practices.
- b. **GAD Webinar 2: GMEF Unboxed: Measuring Impact and Strengthening Gender Mainstreaming (June 17, 2026)** – Providing participants with an in-depth understanding of the updated framework to enhance gender mainstreaming and gender-responsive planning, implementation, and evaluation.
- c. **GAD Webinar 3: Moving Beyond 5%: Championing Gender-Responsive Planning and Budgeting (September 9, 2026)** – equipping stakeholders with practical skills in GAD planning and budgeting to ensure effective gender-responsive PAPs formulation and resource allocation.

- d. **GAD Webinar 4: Making Care Count: Understanding Unpaid Care Work and the Care Economy (October 21, 2026)** – highlighting the value of the care economy, including unpaid care work and recognizing the importance of integrating care work in policies, plans, programs/projects, services, and activities as part of the overall gender mainstreaming strategy.

4. As a gender-responsive institution and a committed partner of the PCW, the Department of Education (DepEd) remains steadfast in providing meaningful learning opportunities and capacity-building initiatives for its human resource on GAD. These initiatives support the continuous strengthening of competencies of its workforce in gender mainstreaming, GAD planning and budgeting, and other related areas essential to fostering gender-responsive policies, programs, and services.

5. In view of the foregoing, interested employees, particularly members of the GAD Focal Point System (GFPS) across governance levels, may participate in the webinar series, subject to the following conditions:

- a. Compliance with the applicable provisions of DepEd Order No. 046, s. 2022 titled the Amendment to DepEd Order No. 43, s. 2022 (Omnibus Travel Guidelines for All Personnel of the Department of Education) and Other Appropriate Orders and Guidelines on Travel;
- b. Secure approval from respective authorities;
- c. Participation shall not interfere with regular functions and responsibilities; and
- d. Use of DepEd funds strictly adheres to the usual budgeting, accounting, and auditing rules and regulations.

6. To confirm attendance, participants are required to use their own unique email address during registration. **Registration links shall be released by PCW according to their prescribed schedule.** Hence, all interested personnel are strongly encouraged to particularly monitor the PCW Facebook page and official website, as **slots are limited and will be filled on a first-come, first-served basis.**

7. Participants are likewise strictly reminded to use the same email address for registration, completion of the activity and resource person evaluation surveys, and the post-test. 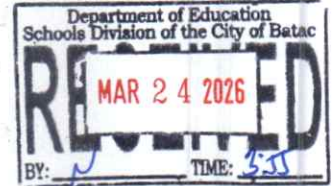
