IN THE DIVISION OF THE CITY OF BATAC**

1. In line with the Department of Education's commitment to providing inclusive and accessible education for all, the Schools Division of the City of Batac will conduct a comprehensive Alternative Learning System (ALS) mapping to identify potential learners who are out-of-school youth (OSY) and adults in need of alternative education opportunities in the different Barangays of the City of Batac.
2. The ALS mapping aims to:
  - a. Identify and locate all potential and existing ALS learners within the division.
  - b. Gather accurate and updated data to facilitate effective planning, enrollment, and delivery of ALS programs.
  - c. Strengthen collaboration between DepEd, local government units (LGUs), and other stakeholders in promoting ALS programs.
  - d. Ensure inclusive education in accordance with DepEd policies and guidelines.
3. This activity is conducted in accordance with DepEd Order No. 34, s. 2016: "Guidelines on the Alternative Learning System (ALS) Implementation", which emphasizes the identification, registration, and tracking of ALS learners to improve access and delivery of basic education services.
4. All ALS implementers, in coordination with local government units, barangay officials and other concerned stakeholders, are requested to conduct house-to-house visits, community surveys, and advocacy campaigns from May 1, 2026 to May 30, 2026.
5. A consolidated report of the ALS mapping results, including the number of potential learners per barangay, must be submitted to the Division ALS Focal Person on or before June 15, 2026.


