PARTICIPATION TO THE 2026 PALARONG PAMBANSA

1. Pursuant to Regional Memorandum No. 511, s. 2026 titled Region 1 Athletic Association (R1AA) participation in the 2026 Palarong Pambansa and related matters, the 2026 Palarong Pambansa will take place from May 18 to June 1, 2026 in the Province of Agusan del Sur.
2. The R1AA delegation will be hosted at Salvacion Elementary School and Salvacion National High School situated in Bayugan City, Agusan del Sur.
3. All Athletes, Coaches, and Chaperones (ACCs) arrival in Butuan City should be scheduled from May 18 onwards but not later than May 20, 2026. The schedule of activity are as follows:



6. All ACCs and other officials are encouraged to bring essential items including complete beddings, eating utensils (lunch boxes, utensils, glasses/cups), and bags for take-out meals. Additionally, they should pack playing equipment and training necessities for the competition, including but not limited to chess boards, rackets, vaulting poles, and throwing equipment. The use of single-use plastics is strictly prohibited in Agusan del Sur; hence, participants are encouraged to bring reusable and eco-friendly alternatives.
7. ACCs are encouraged to bring their previous R1AA playing attire. Additionally they have the option to bring any previous Division/R1AA uniforms, if available, in addition to the general and playing attires to be provided by the Regional Office.
8. The accomodation of ACCs will be at the designated billeting school. It is expected that everyone will reside there for the entire duration of the Palarong Pambansa for the welfare and safety of everyone.
9. Service Credits and Compensatory Time-Off (CTO) equivalent to six (6) days shall be granted to teachers, who will serve as delegation officials/working committee, coaches, chaperones, paramedics, team managers and training staff during the palarong proper subject to existing guidelines on the grant of Service Credits and Compensatory Time-off.
10. The entire R1AA delegation is required to always maintain proper decorum and discipline, ensuring compliance with policies on learner Rights protection, NO SMOKING, NO LIQUOR, NO GAMBLING, and NO BULLYING. Violation will result in ineligibility to participate in future local meets and plarong pambansa as part of the official delegation. In the case that DepEd personnel commits such violations, he/she will face a ban or suspension from participating in future school sports competitions. The duration of this ban or suspension, ranging from one (1) to three (3) years, will be determined based on the gravity of the offense. This disciplinary action will be implement without prejudice to the individual's liability (civil, criminal, or administrative) under other relevant laws, rules, and regulations.
11. This Memorandum shall serve as the Official Authority of Travel for all participants.
12. For immediate dissemination and guidance of all concerned.
