RE-ECHO TRAINING: UNIVERSAL PREVENTION CURRICULUM (UPC) ON SUBSTANCE ABUSE

1. Pursuant to DepEd Order No. 30, s. 2018 otherwise known as the Preventive Drug Education Program (PDEP) Policy for Curriculum and Instruction, the Schools Division of the City of Batac shall conduct the training on Universal Prevention Curriculum (UPC) on Substance Abuse on June 24, 2026 at 8:00 o'clock in the morning at the SDO Conference Hall.

2. The activity aims to strengthen the capacity of school heads in implementing evidence-based, developmentally appropriate, and context-sensitive school-based prevention interventions on substance use thereby promoting the holistic well-being of learners and fostering drug-free learning environments.

Specifically, the activity aims to:

- a. explain the key concepts, principles, and framework of the Universal Prevention Curriculum (UPC) Curriculum 5 on School-Based Prevention Interventions;
 - b. describe the risk and protective factors influencing substance use among adolescents and their implications in the school setting;
 - c. discuss evidence-based and developmentally appropriate strategies in delivering substance use prevention programs; and
 - d. explain the role of the prevention manager, supervisor, parents, stakeholders and prevention practitioner to come up with realistic approach in the prevention of drug abuse.
3. Participants in this activity are the public elementary and secondary school heads.
4. Expenses relative to the activity shall be charged against Sub-ARO No. RO1-26-101 subject to the usual accounting and auditing rules and regulations.
