- **City Social Welfare and Development Office (CSWDO):** *Republic Act No. 9344 (Juvenile Justice and Welfare Act)*

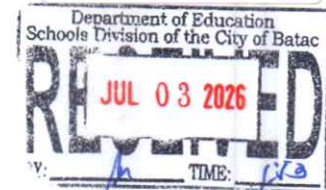
Due to the limited time allotted for each session and in observance of the new DepEd guidelines, the designated lead office for each schedule is indicated in the attached program.
